CANCEL PER KEVIN FORGUE UNTIL 4/8/03** (Con't from 12/3/02) SE49-377 Notice of Intent as filed by Community Boating Center, Inc. for property located Rogers St. and Padanaram Ave, map 17A lots 104 & 105.
